

Dear Mr. Norris:

On September 24, 2015, a discharge line break occurred on the 10,000 gallon Sodium Bisulfite storage tank at Moccasin Bend Wastewater Treatment Plant. Sodium bisulfite is a highly corrosive chemical used to de-chlorinate wastewater effluent prior to release into the Tennessee River. A temporary repair was made to keep the plant operating but it was considered only a short-term fix. Preparations for an emergency purchase to replace the tank were started September 29, 2015. Quotes were obtained from three suppliers as shown on the attachment. The lowest complete quote was from Liquid Handling Equipment, Inc. for \$33,840.

Emergency Purchase Order 535004 was issued to Liquid Handling Equipment, Inc. on October 2, 2015. Delivery is expected in three to four weeks. The temporary repair made at the plant is being closely monitored in the interim.

This emergency purchase was justified by the Public Works Department as in the City's best interest.

Council approval is recommended for the emergency purchase of a Replacement Sodium Bisulfite Tank for Waste Resources from Liquid Handling Equipment, Inc.. in the amount of \$33,840.

Around September 24, 2015, a break occurred in the discharge line of the Sodium Bisulfite Tank. A temporary repair was made, but it was only a short-term fix. Besides the obvious risk of a chemical spill due to the broken line, we would also risk a Permit violation if we were unable to properly dechlorinate the Plant Effluent. As a result, the emergency purchase of a new Sodium Bisulfite Tank from Liquid Handling Equipment, Inc., for approximately \$33,840.00 was requested and approved by Bonnie Woodward, Purchasing Director, on September 29, 2015.

In my opinion, this emergency purchase is justified and the City's best interest is served by this decision.
