


Council approval is recommended to increase the spending limit for the Wet Weather Polymer blanket contract for the Waste Resources Division of the Public Works Department. This blanket contract with Polydyne Inc. started in June 2011 and to date has provided \$96,600 of wet weather polymer for Waste Resources. Wet weather polymer is used to accelerate separation of solids and liquids in the waste treatment train used when rain has greatly increased flow into the waste treatment plant. The annual usage for this blanket contract, originally estimated at \$20,000 per year, has been approximately \$45,000 per year. Usage is difficult to estimate accurately since it depends entirely on the weather.


