# CALL TO ORDER

Council Chairman Jerry Mitchell called the meeting to order with Vice-Chairman Ken Smith and Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, Chip Henderson, Darrin Ledford and Erskine Oglesby. Phil Noblett, Deputy City Attorney, and Nicole Gwyn, Council Clerk, were also present.

Chairman Mitchell led the Assembly in the Pledge of Allegiance.

# SPECIAL PRESENTATION

# Proclamation - "Fair Housing and Compliance Week"

By Antonia "Toni" Morgan and Vanessa Jackson Granted by Permission of Chairman Mitchell and Vice-Chairman Smith

Ms. Jackson began by reading a quote by Dr. Martin Luther King, Jr. that said: "If you can't fly then run, if you can't run then walk, if you can't walk then crawl, but whatever you do you have to **keep moving** forward." She discussed April 4, 2018 being the 50<sup>th</sup> anniversary of the assassination of Dr. King. She also discussed how his assassination influenced the Civil Rights Act of 1968, known as the "Fair Housing Act." Ms. Morgan discussed April 23-26, 2018 being "Compliance Week" in the City of Chattanooga and the list of events scheduled. They also discussed the Fair Housing Conference, including a luncheon, on April 20. Ms. Morgan and Ms. Jackson then proclaimed the following on behalf of Mayor Berke:

**Whereas:** It is important that City of Chattanooga employees and the community are reminded of complying with local, state, and federal policies; and programs

Disabilities Act (ADA), Limited English Proficiency (LEP), Code of Conduct for City employees, Title VII, and other federal, state and local policies should be provided on a frequent basis; and **Whereas:** In conjunction with the 50<sup>th</sup> anniversary of the assassination of Dr. Martin Luther King Jr., it is also the 50th Anniversary of the Civil Rights Act of 1968, commonly referred to as the Fair Housing Act, and National Fair Housing Month;

**Whereas:** The City of Chattanooga's Compliance Office and the Office of Multicultural Affairs will be hosting a series of presentations on compliance during the week of April 23rd thru 26th and month long educational and outreach activities; related to Fair Housing as well as a Fair Housing Conference on April 20th; and

**Whereas:** The City of Chattanooga encourages citizens, directors and employees to engage in discussions with, and provide training and outreach to colleagues and the community led by various departments on those areas reference therein.

#### ORDINANCE #13295

# AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 25, ARTICLE I, SECTION 25-39, PANHANDLING.

Councilman Ledford requesting a clarification on whether the ordinance has provisions for street performers and musical instruments. Attorney Noblett clarified that there is no provision regarding music, but indicated that the ordinance does reference business restrictions for panhandling. Chairman Mitchell asked for further clarification on street musicians. Attorney Noblett clarified that there is no law against street musicians and that this ordinance does not reference musicians.

Councilman Henderson commented on the current ordinance already in place does restrict panhandling downtown, but that performing downtown was legal. Attorney Noblett confirmed that

performing downtown is legal, but indicated that there were restrictions on the distance between location of the performance and businesses.

Assistant Police Chief Edwin McPherson confirmed for Councilman Henderson that he is not aware of musicians being cited downtown for panhandling. He also confirmed that he does not anticipate a problem with musicians being cited.

Councilman Henderson indicated that there may have been an incorrect version of the ordinance on the website with old language regarding restrictions on charitable and political solicitations in certain parts of the ordinance. Attorney Noblett confirmed that old language had already been removed from the version of the ordinance on tonight's agenda.

Mr. Noblett confirmed for Councilman Byrd that police officers cannot fine \$50 when citing panhandlers because the judicial system is the one that has authority to fine. Mr. Noblett also confirmed that the judicial system also has the power to make referrals to agencies to help those cited to court for panhandling.

Councilman Byrd informed the Assembly that the State law imposes a 30-day penalty for the first offense and 90-day for the second and confirmed with Attorney Noblett that the City's ordinance will enable panhandlers to get the services they need.

Chairman Mitchell expressed his great respect for Councilwoman Berz and Councilman Oglesby, sponsors of this legislation, but he voted "No" vote on this item. Councilwoman Coonrod also voiced her "No" vote.

#### The motion carried, with Chairman Mitchell and Councilwoman Coonrod voting "NO."

#### **District 9 Event**

Councilwoman Coonrod announced a partnership with the NACA of Atlanta in bringing the "Homeowners Workshop" to Chattanooga on Saturday, April 14, from 10:00 a.m. - 1:00 p.m. at Greater Second Missionary Baptist Church, located at 810 Shallowford Road. NACA (Neighborhood Assistance Corporation of America) is offering opportunities to purchase an existing home or to purchase and rehab a home. She has flyers to distribute to anyone who needs more information. Councilwoman Coonrod indicated that she is on a mission to have 100 people become homeowners.

#### **Resources for Panhandlers**

Councilwoman Coonrod said she is one paycheck away from being homeless and expressed that many people are in the same situation. She informed the Assembly that the Council is here to ensure that resources are available for panhandlers and those in need.

# RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on nonagenda items. After which, Chairman Mitchell recognized the following persons:

- Landon Howard (Chattanooga/District 2) He wanted to speak on behalf of Mercy Junction and Peace Center on the panhandling ordinance, but Attorney Noblett informed him that he could only speak on non-agenda matters at this time in the meeting. Mr. Howard continued speaking on the panhandling ordinance by discussing a court ruling on alms. Councilman Henderson called for a *point of order* and asked Mr. Howard at least twice to be courteous towards the rules of the Council and refrain from speaking on this agenda matter. Attorney Noblett informed Mr. Howard to discuss only non-agenda matters during this time. Mr. Howard informed the Council that he is working with a law center on homelessness and poverty, and that a letter had been sent to the Council describing alms being protected. He believes the city's panhandling ordinance would be deemed unconstitutional and struck down in other cities because it is "content-based."   - An unidentified woman joined Mr. Howard at the podium and made a statement about a musician who was arrested for panhandling, but yielded the floor with Mr. Howard.
- Edward Green, Jr. (Chattanooga) Mr. Green is the 3<sup>rd</sup> Vice-President of the Tennessee Association of Elks. He informed the Council of the Elks' 73<sup>rd</sup> Convention coming to Chattanooga on April 28. He stated that he had extended invitations to the Mayor and the Council to participate in greeting individuals who will come to Chattanooga from all over Tennessee. The deadline for RSVP was March 31. He indicated that he has not heard from the City of Chattanooga, the Hamilton County Commission, the Police Department or Fire Department. He was "appalled" to have not gotten a response from the Council, with invitations having been extended especially to three Council persons (Smith, Coonrod and Byrd). He concluded by expressing his sympathy to Councilwoman Coonrod on behalf of his organization in the loss of her mother. He also agreed with her sentiments on being one paycheck away from disaster.
- Christopher Dahl (Highland Park) He informed the Council that he is tired of taxpayer dollars going to developer interests and that he would rather have more attention being paid to sewer issues. He would like more smart development in the city.
- Joel Willis (Chattanooga) Mr. Willis wished to address the Council, but Chairman Mitchell informed the Council that his name was on the list of non-agenda speakers who had spoken twice in 30 days. Mr. Willis yielded to the rules of the Council. He indicated that he would speak after the meeting to the Council.
- **Bobbi Such (Rosemont Drive/District 9)** She has been trying 6-7 weeks to get on the agenda regarding rezoning for her C-2 home to be included in the Short-Term Vacation overlay. She said that the overlay stops on the road in front of their house. Councilman Henderson asked for her address. She identified it as 3207 Rosemont Drive.
  - Councilwoman Coonrod informed Ms. Such that Glenwood, including Rosemont, had been added in the overlay when the ordinance and maps was revised about three weeks ago.
  - Ms. Such said that Land Development told that her address needs to be added individually to a resolution to be included.
  - Chairman Mitchell asked Donna Williams, Administrator for Economic and Community Development, to speak with Ms. Such about this matter after the meeting.
  - Chairman Mitchell also asked about the name of the baby that Ms. Such was holding. Ms. Such said her baby's name was Geronimo.
