COUNCIL MEETING MINUTES

June 26, 2018 6:00 PM

CALL TO ORDER

Council Chairman Ken Smith called the meeting to order with Vice-Chairman Erskine Oglesby and Councilpersons Carol Berz, Anthony Byrd, Russell Gilbert, Chip Henderson, Darrin Ledford and Jerry Mitchell. Wade Hinton, City Attorney, and Nicole Gwyn, Council Clerk, were also present. Councilwoman Demetrus Coonrod was not present this meeting.

PLEDGE OF ALLEGIANCE

Vice-Chairman Oglesby led the Assembly in the Pledge of Allegiance.

AN ORDINANCE HEREINAFTER ALSO KNOWN AS "THE FISCAL YEAR 2018-2019 OPERATIONS BUDGET", PROVIDING REVENUE FOR THE FISCAL YEAR BEGINNING JULY 1, 2018, AND ENDING JUNE 30, 2019; APPROPRIATING SAME TO THE PAYMENT OF EXPENSES OF THE MUNICIPAL GOVERNMENT; FIXING THE RATE OF TAXATION ON ALL TAXABLE PROPERTY IN THE CITY, AND THE TIME TAXES AND PRIVILEGES ARE DUE, HOW THEY SHALL BE PAID, WHEN THEY SHALL BECOME DELINQUENT; PROVIDING FOR INTEREST AND PENALTY ON DELINQUENT TAXES AND PRIVILEGES; AMENDING CHATTANOOGA CITY CODE, PART II, CHAPTER 2, SECTION 2-267, RELATIVE TO PAID LEAVE FOR ACTIVE-DUTY TRAINING AND TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 31, SECTIONS 31-36, 31-37, 31-41, AND 31-43, SECTIONS 31-322 AND 31-354.

Discussion ensued with the Council and Attorney Hinton about where amendments may be made and whether the amendment affects both the operations budget and capital budget.

Councilman Henderson moved to offer an amendment. He was seconded by Councilman Mitchell. His amendment would add three things:

- Equity study on rate structure
- No tax increase on water quality fund
- Authorize Administration to take up to \$2,000,000.00 from reserves if necessary

He indicated that he had briefed the Council on his proposed amendment in their meeting earlier today. Councilman Ledford confirmed with Stacy Richardson that seniors covered by the tax freeze would have the water quality fee waived. She discussed doing an equity study if the amendment fails and the program is funded as currently proposed. In response to questions from Councilman Ledford, she discussed the impact on the bond rating and the impact of planned projects.

Stacy Richardson, Chief of Staff, responded to further questions about the need to deal with water quality now and the need to work on the 5-year plan if the amendment passes. She discussed the impact on reserves, sustainability of the water quality program and delays in items further down the line.

Since Opposition was present, Chairman Smith allowed time to hear from both the Applicant and the Opposition. He then recognized the following:

• **April Pardo** (Chattanooga) – Her company owns several short-term vacation rental properties in Chattanooga. She has paid her insurance for this property and will maintain the property herself. She responded to Councilman Henderson about speaking to her neighbors next door and across the street about the property.

On behalf of the Opposition:

- Sergeant Wyse (Chattanooga) He indicated owning several properties in the district, including long-term rental properties on 602 Van Dyke, 330 Stringer Street and 528 Cherokee Boulevard. He gave the Council a copy of a letter from his father, John Wyse, who adamantly opposes the STVR. He then proceeded with reading his own statement before the Council. He opposes the neighborhood being a "tourist" location. He does not believe STVR benefit anyone other than the property owner. He does not want to see his short-term renters in and out. He is more concerned with the social aspects than safety issues.
 - Mr. Wyse responded to questions from Councilman Henderson about the permit for owner-occupied and non-owner occupied properties.
- **Cameron Becker** He is concerned with safety and opposes short-term renters coming in and out of the neighborhood.

Rebuttal:

Ms. Pardo has not had any complaints. She will be hands-on maintaining this property. She does not have a management company working for her. She picks up the trash at her property as well as her neighbors' trash.

 Councilman Henderson informed the Council that he spoke with the assessor and has been told that STVR will not bring down the property values in this area. He noted that with nonowner occupied properties, it would only take two violations to lose the right for the STVR.

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Smith recognized the following persons:

- Quenston Coleman (Chattanooga) He has served on boards in Cookeville, TN and the Industrial Development Board in Chattanooga. He has lived in Brainerd since 1967, but lived in the downtown area before then. He is concerned with the Innovation Zone Plan of the City and its potential to erase historical documentation in the I-Zone area. He voiced concerns about the Bessie Smith Cultural Center not promoting the African American Museum. He suggests putting these entities under the downtown library. He reminded the Council of African American history in Chattanooga. He would like to see a Chattanooga that maintains what African Americans have contributed.
- Christopher Dahl (Chattanooga) He would like to see the Council fix its rules, which he believes are unconstitutionally-sound. He send an email previously to the Council via the Mayor's Office about the limits on free speech in the public forum.
- Rick Carpenter (Chattanooga/District 4) He spoke on the constitutionality of free speech in public forums, such as this Council meeting. He questioned the Council on why there were limits to people speaking at the Council meeting. He questions why some comments are banned by constituents based upon Council rules regarding what is "derogatory" speech. He believes this Council is silencing the community, which he believes is disparaging to constituents.
