Mr. Bridger briefed the Council on this item. He discussed the concerns from residents and the previous 60-day deferral on this item. He discussed the Applicant meeting with the community and revising the site plan to include four (4) distinct structures, one fronting Highland Park Avenue on the East and the others fronting the street on the South, which was a concern for residents initially. He discussed the recommendation of Planning and Staff for approval with conditions.

On behalf of the Applicant:

 Bob McNutt (CNE) – He informed the Council of meeting on two occasions with the neighborhood on this to modify the site (conceptual) plan. This came before the Planning Commission three months ago, where there was Opposition. He indicated that there would be no effect on zoning since UGC is needed regardless. He indicated there there are three building types and that the plan is not finished. He informed the Council that the neighborhood was content. He knows that this has always been a difficult site, but argued that the R-4 is not appropriate since the former dormitory has been demolished on this site. The Opposition:

• **Christopher Dahl** – He lives around 12<sup>th</sup> & Willow. He believes that since CNE is funded with taxpayer dollars, the meetings were supposed to be recorded in minutes and, if not, then video, but they were not. He has concerns about storm water runoff still and wants a business to move into the vacant commercial spot prior to allowing this rezoning.

Rebuttal: Mr. McNutt informed the Council that he did not record the meeting because it was not his meeting; it was the neighborhood's meeting. He also indicated that storm water would be managed under the existing property. Upon no further questions or comments, the motion carried.

# RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read the rules of procedure for persons wishing to address the Council on nonagenda items. After which, Chairman Smith recognized the following persons:

- Monty Bell (Chattanooga) He would like to have his driver's license reinstated. It was suspended in 2012. He believes the law that was forced upon him was unconstitutional. He believes it is unconstitutional to suspend a person's license because they cannot pay a debt. He was in a pool of thousands of Tennessee residents whose licenses were pooled after the law was passed in 2012. He believes he has been targeted for filing litigation against authorities. He told about a good friend who is a police chief in Georgia who made a phone call in his support. He was escorted from Georgia to Tennessee regarding his license, but is still working to get it reinstated. He said it would be a "Christmas gift early."
- Marie Mott (Oak Grove Neighborhood) She is working with a faith-based initiative to seek justice for the two black women who were dragged out of their vehicles by their extremities recently by Chattanooga police officers. She cannot imagine it happening to her child or her mother. She reminded the Council that power has been extended to councilpersons and the Mayor by the People. She does not believe paying people off will remedy injustices. She believes that "two Chattanoogas" exist where there is an economic and social divide. She says that enough is enough and that she is demanding involvement from the Council. She put the Council "on notice," and will work to secure 1,000-plus signatures to recall the Mayor if something is not done about these two cases.
- Nathan King (Gay Street/Eastdale) He read the recent article in the Chattanooga Times Free Press regarding the Wallet Hub survey that ranked Chattanooga as one of the "worst-run cities in the Country," based upon 35 criteria. Chattanooga ranked seven below Flint, MI. He was thankful for the two "no" votes on the budget recently. He sees more money going into the police and prisons than into social programs. He reminded the Council that the People requested participatory budgeting a year ago. He believes Chattanooga is one of the worst-run cities. He mentioned the cases of Jabari Eagle and Angelique Moore. He discussed an Internal Affairs report implicating a former CPD officer of planting evidence. He believes this city needs true civilian oversight of the CPD that includes citizens, not just other CPD officers.
- **Tiffany Rankin (Lincoln Park)** She reported that the roof of a car wash had been blown off during a storm and left in the trees in Avondale. She asked that Public Works remove the roof.
  - Councilwoman Coonrod asked Donna Williams, Administrator for the Department of Economic and Community Development, to explain the process regarding the carwash roof in the tree. Ms. Williams informed the Council that the insurance company advised the carwash owner regarding

the roof and demolishing the building. Code Enforcement has overseeing the demolition of the carwash. The City can now remove the roofing.

- David Tullis (Chattanooga) He works at 92.7 Nooga Radio. He questioned if CPD is under control, and if the Executive branch is managing it. He discussed the June 25 arrest of the youth and noted that the officer taking the youth into custody did not have a court order to intervene in a car repossession. He discussed "mass armed presence" during the recent arrest of Dianna Watt. He believes there is a distemper in the police department. He questions why there is always a threat at the end of engagements with citizens. He reminded the Council that he had given notice to the City about Title 55 defining private users of roads. He noted that there is a right of travel and free movement. He believes reform must take place here, including the CPD.
  - Councilwoman Coonrod would like explanations on the recent traffic stops. She requested the policy in traffic stops and the policy on use of force from Assistant Chief Eric Tucker. He made comments on traffic stop citations and warnings, and if the refusal to sign a traffic citation is enforceable. She is concerned with the culture of the CPD being more aggressive with certain communities during traffic stops. She commented about CPD working with and understanding the communities they serve.
