Minority Health Fair

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Smith recognized the following persons:

- **Mike McMahan** (Ridgeside Dr.) He is a past City Attorney and worked with Attorney Noblett for 28 years. He described Attorney Noblett as a man of integrity, keen intelligence and a great work ethic.
- Christopher Dahl (Chattanooga) He thanked the Council for allowing him to speak after being unable to do so a few weeks. He especially wished he could have spoken out on the shooting on Bennett Street. He feels the Council should be looking at the increase in fees and flooding in the city. He believes that other areas of the city can use some attention. He informed the Council that people want to know about the rape allegations against a city police officer.
- Marie Mott (Oak Grove) She read a famous quote by Dr. Martin Luther King, Jr., then proceeded to inquire about the rape allegations against the Chattanooga police officer. She also inquired about two (2) recent incidents of police force used with Diana Watt and the teenage daughter of Avery Gray. She questioned why there is not enough city funds to address the need for social services. She questioned why the new City Attorney did not help her get the statutes she requested regarding police brutality. She asked the Council to say where they stood on the issues she mentioned.
 - Councilwoman Coonrod requested a response to Ms. Mott's questions on the police incidents she referenced. Assistant Chief Zach McCullough informed the Council that he could not comment on a pending criminal investigation and that it would also need to go through an Internal Affairs investigation. He informed the Council that he was not aware that complaints under investigation regarding the incidents with Ms. Watt and the teenager, but agreed to find out if complaints had been filed and report back to Councilwoman Coonrod.
 - Councilwoman Coonrod also followed up with Attorney Noblett as to why Ms. Mott could not get the information that she had requested in their office. Attorney Noblett explained that Ms. Mott did not wait until their Open Records consul was back in the office to take her request. Ms. Mott disagreed with Attorney Noblett, informing the Council that she and those with her had been escorted from the Office of City Attorney that day.
- Ellen Keef (Middle Valley Road) She is the owner of Gudal's Garage, which has been in service 42 years. She started the process for deannexation a few years ago and had been told on past occasions that the deannexation would be placed on the Council's agenda for consideration. She even showed up to one meeting, but was not on the agenda as expected. She indicated that there is a statute that would allow her property to be deannexed because she has not had sewer for the past three years. She argued that she does not have hydrants or other benefits as a part of city government. She also discussed problems with road work and car crashes on her end of Middle Valley Road. She asked that her deannexation petition be placed on the Council's agenda next week.
 - Chairman Smith informed Ms. Keef that her deannexation was not placed on the agenda because city departments do not support her claim. He informed her that department investigation shows that her property is within

 100-feet of sewer. He offered to set up a meeting for Ms. Keef and city department heads to discuss the city's paperwork and findings. Ms. Keef still does not agree with what Chairman Smith has been told, but she agreed to the meeting.
