OTHER BUSINESS:

Travel Donation

Maura Sullivan, Chief Operating Officer, reported a travel donation to the Chattanooga Police Department totaling \$2,275.00 to pay for a bus to take officers to the funeral of Officer Galinger. She also spoke words of thanks for the donation. Councilman Henderson inquired about the transportation arrangements. She informed the Council of the four escorts to Cincinnati and the Honor Guard. She offered to send further information as it is finalized. Chairman Smith asked about other donations. Ms. Sullivan informed the Council that donations may be made to the Police Memorial fund or the American Cancer Society.

Avondale Housing Program

Councilman Byrd announced that he took part in a neighborhood program this week on Main Street about an owner-occupied duplex program. He asked only Donna Williams, Administrator for Economic and Community Development, to discuss the pilot program. Ms. Williams informed the Council that the city and county used to own three properties. The county gave the properties to the city; however, they were blighted. She informed the Council that this pilot program is only for the Avondale Neighborhood Association. She noted that this is not a city-wide program and only covers these three properties.

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on nonagenda items. After which, Chairman Smith recognized the following persons:

- Edward Green (Gayle Dr.) He came to the Council about his driveway located on a dead-end street. He came before to address the Council back when Lee Norris was Public Works Administrator. He indicated that Councilman Gilbert and Councilwoman Berz were on the Council when he came the first time. He informed the Council that city garbage trucks have used his driveway to turn around every Monday for the past 15 years. His driveway is now showing damage because of overgrowth. He informed the Council that Public Works cleaned the overgrowth coming over his fence. He requested that Public Works come out to see his driveway to see the damage to his driveway. He completed a claim form today for damages, but did not receive a service claim number.
 - Chairman Smith asked Mr. Green to stay after the meeting so that he could assist him.
- **Christopher Dahl (Chattanooga)** He had a grievance with the Council for negligence and informed the Council that he pulled onto Hamill Road this weekend around 10:55 p.m in an attempt to remove up a metal road sign that had fallen from the barricade at a sewer breach. He could not move the sign due to the heavy traffic and due to the He pulled off and left the scene at 11:02 p.m. He saw a CPD car pull into the driveway across from the

breach. He was upset with because in March 2016, the Council approved funds for the Dupont pump station and basin improvement funds to alleviate sewer overflows in that area. He did not observe proper signage at the barricade on Hamill Road per the manual on uniform traffic control devices. If one looks at the manual, he indicated that the signage placement before a barrier is based on scenario. He informed the Council that he pulled off right before the accident on Hamill Road occurred and expressed condolences to the officer that passed away and the Chattanooga Police Department.

- Assistant Chief McCullough informed the Council that CPD will put out a news release with details about the officer funeral.
- Kristin (Missionary Ridge) She distributed pictures to the Council. She came to inform the city about the drainage in her grandmother's yard. The city installed a drainage that has become life-threatening to her replaced a sinkhole years ago in the 1970's. The city took responsible for that sinkhole and repaired it. In the 1980's, the city dumped rocks at the drain. Another sinkhole took place in 2005. The city determined then that they were not responsible for the erosion. Her grandparents used their own money to fix the second sinkhole appeared in their yard again. In 2017, her grandparents' neighbor was sitting and a tree sitting on the city's drain fell over the neighbor's Suburu about eight minutes after getting out of it. The city dumped rocks on her grandparent's private property again and, she believes, could've claimed both grandparents' lives. On June 6, 2018, a hole fell out beside her grandmother's feet. She believes her grandmother could have died. Her family came in July 2018 to address the Council. The city promised to come out during that Council meeting. When they did, the city only cleaned the drain 100 feet away from the actual hole. Public Works has been notified over 25 times about this situation. There is now a new 6'x6' hole open above the drain now. All water from South Crest is running into their property from two different properties. The area of their patio is about to collapse. The city will not move the inlet of the water because it is on private property. She believes the city is responsible for continued damage on their property.
