John Bridger, Executive Director of Regional Planning, made a presentation on this case, giving the Staff and Planning Commission reports. He noted that this property as currently being used for storage and that noted that there is enforcement matter in progress for this property.

Councilman Gilbert informed the Applicant that he has not seen a site plan and has received complaints over the last 2-3 years regarding the appearance of the site. He asked the Applicant to explain what will be done to improve the appearance.

Applicant:

- **Pryor Bacon (Chattanooga)** - His wife owns the title to the property. He does not feel that his intended use is out of the character of the community since the junkyard on the west is M-1, the railroad is R-1 and the east is undeveloped C-1. His rear portion is R-1. He has accumulated 50 years of construction materials on the premises. He does not know of anyone other the Councilman who has heard from the opposition. Regarding the floodplain, he would not store anything down below and plans to elevate it on the second floor for a self-storage facility.

Councilman Gilbert informed the Applicant that he does anticipate putting conditions on the rezoning, so he would like to defer for 30 days so that the Applicant can meet with the community and discuss the site plan. Mr. Bacon indicated that he did not think coming back to the Council in 30 days would make a difference. **Councilman Gilbert moved** to deny, seconded by Councilwoman Berz. The motion carried.

**RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL  
(Non-Agenda Items)**

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items and noted that the Council's rules of procedure had been changed by resolution earlier in the meeting. He informed the Assembly that the new rules would take effect next week, which included limiting the time for non-agenda speakers to three minutes per person. After comments from the attorney, Chairman Smith recognized the following persons:

- **Marie Mott (Chattanooga)** - She came to discuss the recent incident at Dalewood Middle involving Hamilton County Sheriff and CPD officers who responded. She informed the Council that a petite 13-year-old was restrained with the officers' knees on her back. She informed the Council that the community is upset with the police brutality and excessive force seen by this Council. She has heard the conversations about a police advisory board or keeping the current Administrative Review Committee at CPD. She indicated that black people are here today because they have fought to be here. She believes Chattanooga is soiled with blood because of a issues that everyone knows is wrong. She encouraging

fighting with the people if you cannot meet with the Mayor. She asked the City to act on what the people ask regarding children being brutalized by officers.

- **Patricia Young (Chattanooga)** - She is trying to get her lights turned on in the back of her house. She was informed that she missed the 90-day deadline. She lives in District 9. She informed the Council that her privileges were lost while her lights were out longer than 90 days. She also showed pictures of her property.
  - Councilwoman Coonrod was aware of Ms. Young's situation and informed the Council that Ms. Young lives in an R-1 Zone. She indicated that a land surveyor would need to come back to check on this.
  - Richard Beeland of Economic and Community Development indicated that he would speak with Ms. Young after tonight's meeting.
- **Monty Bell (Chattanooga)** - He wanted to give a reminder to the Council about the Dred Scott case, in which an enslaved man sued for his freedom. He feels that he has been treated like Dred Scott. He feels he is like Dred Scott because he, too, has a deep heritage. He has come before the legislative body for 26 years and continues with his lawsuit. He discussed making history with journalist Melydia Clewell. He will be talking on Mr. Tullis's radio show on tomorrow. He talked to the Superintendent about being one of the writers of the proposal that changed the name of the Brainerd High School "Rebels" to "Panthers."
