The motiviation to run a STVR was his wife wanting to get back into the workplace, but choosing to be a full-time mom. He also noted that English is her second language, so STVR works well for her. His wife's family lives overseas, so they would like to have this property for his relatives who come to visit for one to six months.

## Opposition:

• Anna McMillan (Colville Street) – She is against STVRs because vacationers do things in the rentals that they wouldn't do at home. She believes there are too many STVRs in this area and was told by her neighbor that there are 100 STVR in this community.

## **OTHER BUSINESS:**

# East Chattanooga Improvement, Inc. (ECI)

Councilman Byrd asked the Chair to recognize two individuals from the Avondale community: James Moreland and Ken Smith, officers of the Avondale Neighborhood Association. Chairman Smith gave them the floor.

Mr. Moreland informed the Council about ECI, which consists of eight (8) neighborhood associations in the East Chattanooga community and meets the last Tuesday of every month. Formerly known as the East Chattanooga Task Force, Mr. Moreland discussed the background of ECI in relation to the Tubman site. He distributed information to the Council that discussed ECI's concern about the Tubman site. [See attached.] He voiced concerns about outside organizations coming into East Chattanooga regarding the Tubman Site without attempting to work with neighborhood associations there.

Councilman Byrd expressed his support of the associations of ECI and committee to relaying information to ECI. Chairman Smith expressed kudos to the ECI associations for joining together despite being distinctly different.

# **Interlocal Agreement**

Councilman Henderson informed the Assembly of the Public Works Committee meeting earlier today and hearing about WWTA contractual agreements. He asked Mr. Holland about deficiencies that might be gained. Councilman Henderson asked the City Attorney to prepare a resolution to adopt an interlocal agreement with Hamilton County to conduct a benefit analysis

study concerning consolidated services between Moccasin Bend, Wastewater Treatment Plant and WWTA. Councilman Smith asked for the resolution to be on next week's agenda, if the Council so desired. A discussion ensued about when the resolution would go to agenda. Councilwoman Berz inquired about the resolution going to committee first and also inquired about whether the resolution would be discussed in Strategic Planning meeting prior to committee. Councilman Mitchell noted that there is Opposition to the interlocal agreement. When asked by Chairman Smith, Mr. Noblett noted that the resolution could be done in two weeks. Upon no further discussion, the Council came to a consensus to discuss the resolution in two weeks at the next Public Works and Transportation Committee meeting. After which, the Council will have a one-week review period.

# RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Smith recognized the following persons:

- **Tiffany Rankin (Lincoln Park)** She is the secretary for the Lincoln Park Neighborhood Association. First, she wanted to respond about ECI. Her mother has been active in the ECI for years. Lincoln Park had requested to be part of Area 7, but had not been included as of yet. She just wanted to confirm that.
- Helen Burns Sharp (Chattanooga) She represents ATM, Accountability with Taxpayer Money. ATM is one of a collective of eight organizations working almost exclusively to bring a community benefits agreement to the Tubman Site. She named several organizations that are part of the collective, including The Unity Group and Concerned Citizens for Justice. She did not know that others in the Avondale community were working on a community benefits agreement, which is the purpose of the coalition. She is not a spokesperson for the coalition, but sees a lot of common ground between the coalition she's been working with and the ECI.
  - Councilman Byrd commented on Mr. Smith wanting to work with everyone. He believes this is a good opportunity for all parties to buy-in. He noted that ECI would like to be put in the loop and would like to work with those doing the door-to-door knocking

**BACKGROUND INFORMATION:** In 2014 *The* Harriet Tubman Site was purchased by the City of Chattanooga from the Chattanooga Housing Authority after a very strong request from the Avondale Neighborhood Association with the support from eight other associations in the East Chattanooga Area (East Chattanooga Improvement, Inc). The Tubman Complex had a history of many negatives that the community did not want the complex to be opened back up as a housing unit. After much discussion from the Avondale Association an agreement was reached that the city to purchase the site for Job creation.

# Weed & Seed Steering Committee Celebrates \$1 Million Grant Opportunity with the Community

September 27, 2007 - Today, members of the East Chattanooga Weed & Seed Steering Committee joined Mayor Ron Littlefield and Chattanooga Housing Authority Executive Director Bob Dull in celebrating a five-year, \$1 million grant designed to create safer places

The U.S. Department of Justice recently awarded the first funding cycle of the East Chattanooga Weed & Seed grant initiative, which officially starts on Monday, Oct. 1. Sgt. Doug Edmisten, the Weed & Seed liaison representing the U.S. Attorney's Office, also took part in today's press conference where officials shared their high expectations for the grant.

"This is going to allow us to take back our community," said James Moreland, chairman of the East Chattanooga Weed & Seed Steering Committee. Because East Chattanooga is now designated as a Weed & Seed area, Mr. Moreland said persons who commit certain crimes will be subjected to stiffer federal penalties.

The East Chattanooga Weed & Seed grant will provide federal dollars to "weed" out crime in 11 neighborhoods occupied by 15,000 residents with low- to moderate-income levels. Funds will also be used to "seed" in support services to create structured youth activities and safe havens like the Avondale Recreation Center, as well as to promote neighborhood pride and boost economic development.

"This is a dedicated and determined group of residents who have organized themselves and are addressing the various issues affecting our neighborhoods," Mayor Littlefield said. "What began as the Eastside Taskforce has grown from a grassroots initiative into a collaboration of 11 neighborhoods and although we have a lot of hard work that remains to be done, we are confident that we can accomplish it with the help of this Weed and Seed

From 2004 to 2006, the 11 target neighborhoods in East Chattanooga saw a 50 percent increase in homicides; a 27 percent increase in auto theft; a 25 percent increase in drug arrests; and a 16 percent increase in aggravated assaults. Officials said much of this increase is because of a re-emergence of gang activity in the area.

"We believe brighter days are ahead of us because we'll have more resources to help get rid of the crime in our neighborhoods," Mr. Moreland said. "Whenever a community sees a decrease in crime, there's a better chance of attracting more businesses and creating job for

Last summer, Mayor Littlefield convened a group of community leaders together after two gang-related murders occurred in two public housing communities in a single week. Shortly afterward, City officials decided to apply for the federal Weed & Seed grant with CHA as the

Mr. Dull said the housing authority has a major investment in East Chattanooga because several public housing communities are located in this area.

"We're very close to opening a new housing complex called The Oaks at Camden that will primarily serve working families," Mr. Dull said. "As the Weed & Seed grant initiative develops, I can see East Chattanooga becoming a hub for more affordable housing opportunities and sustainable economic growth." ###
