COUNCIL MEETING MINUTES

March 26, 2019 6:00 PM

CALL TO ORDER

Council Chairman Ken Smith called the meeting to order with Vice-Chairman Erskine Oglesby and Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, Chip Henderson and Jerry Mitchell. Phil Noblett, City Attorney, and Nicole Gwyn, Council Clerk, were also present. Councilman Darrin Ledford was not present this meeting.

PLEDGE OF ALLEGIANCE

Councilwoman Coonrod led the Assembly in the Pledge of Allegiance and invited Sylvester Harris to give the invocation.

SPECIAL PRESENTATION

Proclamation "<u>National Vietnam War Veterans Day</u>" By Councilman Chip Henderson

Councilman Henderson made the following proclamation on behalf of the City of Chattanooga to the Vietnam Veterans of America Chapter 203:

- Whereas, here in 2019, we continue the commemoration that over fifty years ago, our nation ended military involvement in the Republic of South Vietnam, thus ending military involvement in what was then the longest war in our country's history; and
- Whereas, it is important to honor the men and women who survived and the over 58,000 men and women who gave their lives; and
- **Whereas**, there were over 10,000 from our Tennessee Valley community that served in the Vietnam War and there were one hundred fifty-six causalities; and
- Whereas, as Chattanoogans, we must never forget the pain and suffering that lingers today for the men and women who fought with honor and distinction, in the name of freedom and democracy for all; and

Whereas, since their return, these veterans have contributed tremendously to our community; and

Whereas, today, we again have the opportunity to honor, give thanks and pay tribute to these men and women who saw our country through one of the most challenging missions we have ever faced and who answered the call of duty with courage and valor; and

Whereas, with this ceremony here today on Wednesday, March 27, 2019, let us strive to continue to show our Vietnam Veterans and their families the fullest respect and support of a grateful Chattanooga Community:

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Smith recognized the following persons:

- Sylvester Harris (Curtis St.) He voiced concerns about the homelessness and mental illness problems in the East Chattanooga community, particularly at Midland and one adjacent street. There are people hanging out at the gas station in the area. He does not want passersby's to think that this is the norm for East Chattanooga. He asked the Council about passing a loitering ordinance. There is trash in the area and he believes this is associated with people's needs. He informed the Council of the need to clean up these areas and wants to clean up these eyesores. He wants to help people with alcohol, drug and mental illness problems, especially in those two streets.
 - Councilwoman Coonrod informed Mr. Harris that she will work with him in a community cleanup if he would like.
 - O Councilman Byrd informed the Assembly that he participated in a walk-through of that area and encouraged citizens to place service requests with 311 to report waste. He encouraged business owners to report when people are loitering on their properties. He also notified the Assembly that a dumpster will be available in the area in three weeks for a community cleanup.
 - Councilman Henderson informed the Council that there is a group of 320 people coming to East Chattanooga on June 16-21, 2019, to provide free work on 64 homes. He also noted that this was done in partnership with the city's Department of Economic and Community Development.
 - Mr. Harris thanked Councilman Henderson for helping him get vouchers for needy people recently.
- Monty Bell (Chattanooga) He is suing the city for \$24 Million dollars, of which he plans to send \$19 Million to Brainerd High School. He believes there has been a lack of due process since the attorney started as an intern with the city. He believes that he has been denied the ability to come before the Council to address problems in his community. He was arrested in 1992 because he wanted to uplift fallen humanity in his community. He wants the Council to tell him about his money so that he can send \$19 Million to Brainerd High School. He wants to know why UTC did not want him to teach. He wants to know the punitive and compensatory damages. He is demanding his payment now before the city helps the previous speaker.
- Darrion Wood (Chattanooga) He got a parking ticket and was concerned with the fact that the \$11 parking ticket goes up to \$41.50, an extra \$30, if not paid in 10 days. He gets paid every two weeks, so that would be difficult for some working class people, especially since his wife just had a baby. He feels like this extra \$30 is extortion, especially for people who do not have the money within 10 days. He noted that his vehicle could be immobilized. He would like for the Council to lower the fees.
 - Councilwoman Coonrod asked if there was anything the Council could do. Attorney Noblett informed the Assembly about City Code and collections fees.

Councilwoman Coonrod then asked Mr. Wood to leave his contact number with her after the meeting so that she can notify him if the Council can do anything.

- **Kenneth Adams (Chattanooga)** He is a homeless man whose dogs were recently seized and put into a shelter. He wants his pets back because his dogs are his life. He noted that took good care of the mother dog and took it from being an aggressive dog to a passive one.
 - Chairman Smith asked Mr. Adams to speak with the city's Constituent Services
 Director in the back of the Assembly to see if they can contact someone at
 McKamey.
 - Councilwoman Coonrod thanked the labor union for turning out today to show support and solidarity for what is on the Council's agenda. She indicated that seeing people face-to-face in the audience makes a world of difference to her.

[Councilman Mitchell exited the meeting at this time.]
