COUNCIL MEETING MINUTES

April 30, 2019 6:00 PM

CALL TO ORDER

Council Chairman Erskine Oglesby called the meeting to order with Vice-Chairman Chip Henderson and Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, Darrin Ledford, Jerry Mitchell and Ken Smith. Phil Noblett, City Attorney, and Nicole Gwyn, Council Clerk, were also present.

SPECIAL PRESENTATION

Proclamation – Boys Leadership Summit By Councilwoman Demetrus Coonrod

Councilwoman Coonrod presented the following mayoral proclamation to the six (6) organizers of the 2019 Boys Leadership Summit:

Thereas, In the Spring of 2010, author and radio personality Michael Baisden's "1

Million Mentors" Campaign was held in Chattanooga. He challenged the attendees with the following statement, "What are you going to do when I

leave Chattanooga?" and

Whereas, In 2010, a group of men from various organizations with an interest in

helping young African-American males become successful and productive adults, responded to that question and joined together to host the first Boys'

Leadership Summit in October of that year; and

Whereas, The annual event targets males in grades 6-12, as well as college males. It

includes workshops, trainings, and other activities to help attendees learn to cope with issues and problems facing youth today. In addition, organizers have worked with organizations such as Big Brothers Big Sisters, and the Boys and Girls Club of Chattanooga to link boys with access to mentors;

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Oglesby recognized the following persons:

- **Jim Johnson** (Chattanooga) He has been attending meetings with developer for the Publix coming to Broad Street. The opposition has been against what he called "bad suburban development in an urban setting." Once the opposition's concerns reached corporate ears, Publix was willing to address the community's concerns. He read some of what the developer has planned for now. He hates that some people were willing to accept the grocery store at all costs. He believes such an attitude weakened the city's advantage.
- **Christopher Dahl** (E. 12th St.) He brought his son to ask about sewer issues. He noted that there is a pungent smell from Moccasin Bend and from a plant in South Chattanooga. He believes the smells need to be remediated. Regarding a separate matter, he wanted to comment on the city's board process. He believes that board members should be required to sign that they will abide by Robert's Rules of Order.
- Jared Story (Chattanooga) He read a statement from Concerned Citizens for Justice regarding the proposed police advisory and review committee. Community organizations and community members have been wanting an oversight board for the police department for years and have spoken to the Council about it. CCJ asked to defer the currentlyproposed legislation for a community-led oversight board. Their letter to the Council has been ignored. He discussed the type of police oversight board model that CCJ would like to see put in place.
- **Susan Bureau** (Hixson) She wants to know how to give community input on the short-term vacation rentals.
 - Mr. Noblett informed Ms. Bureau about public meetings that will be schedule by RPA and placed on the RPA website. He also explained the process of bringing the matter back by before the Council upon the request of two council member.
