Chairman Oglesby confirmed that both the Applicant and Opposition were present. Therefore, a hearing ensued. John Bridger, Executive Director of Regional Planning, gave the case report that included the case details, zoning history, land use plan, staff and Planning recommendations. After which, Chairman Oglesby opened the floor to hear from the Applicant and members of the Opposition.

Applicant:

• Justin Tirsun – The Applicant prefers more of a townhouse look, so the sidewalk buffer will be reduced to achieve that. They met with the neighbors to discuss their plans. Access will be via Middle Valley Road. R-4 Allows commercial, so they decided to extend the part of the property that is already zoned as R-4.

#### Opposition:

• **Deborah Miller (Shelby Circle)** – She spoke on behalf of herself and her neighbors. She believes that 38 units on 2.6 acres is too much density for the area. She has heard conflicting

information on whether the units will be 2- or 2-1/2 stories. She described the traffic as "horrendous." She asked that if the Council does approve this rezoning, then a traffic light should be installed at the cross section. She noted that there is an auto garage and a daycare in the area which she believes will be impacted by the traffic increase. She questioned if the new residents will be allowed to park boats or RVs at the premise. She noted that there are no sidewalks on Shelby or Middle Valley. She believes that water retention and mosquitos will be a problem and questioned if there are plans for the extra sewer capacity from the units. She is concerned with property values once the apartments are added.

Terri Gresham – She came last week. She has 115 people who are voting against this project. She sent a PDF of the petition to the Council. She believes the property is too small for three units. She believes that the traffic is horrible in this area. She is concerned with the physical endangerment of the women, children and elderly in this area. The area needs sidewalks and a traffic light. She is also concerned with water issues.

Rebuttal: Mr. Tirsun thanked the Opposition for speaking with him. He requested that the Council defer this case for four (4) weeks so that he may continue talks with the residents. Chairman Oglesby confirmed that the Council meeting date four weeks from now would be June 11, 2019.

Discussion ensued:

- Councilman Smith acknowledged the concerns of the neighborhood and made comments about the water issues.
- Mr. Bridger confirmed that there were no concerns from CDOT after the traffic. Blythe Bailey, Traffic Administrator, confirmed that CDOT reviewed the traffic with Regional Planning and had concerns at this time. He indicated that a traffic study is not planned at this time, but CDOT may be involved during the permit process.
- Mr. Tirsun confirmed that he had contacted the neighborhood associations in this area. Mr. Tirsun spoke to the Presidents and Vice-Presidents and offered to attend a special meeting to discuss this project.
- Ms. Gresham agreed to work with Councilman Smith and suggested that Shelby Circle residents be brought into the conversation.

**Councilman Smith moved** to defer to June 11, 2019. He was seconded by Vice-Chairman Henderson. The motion carried.

# **Employee Grievances**

He received text messages today in relation to comments made in an earlier meeting by Councilwoman Coonrod about employees fearing coming to councilpersons with their employment matters. He does not want employees feeling like they cannot talk to the Council. Therefore, he asked Attorney Noblett about recourses for employees who fear the threat of retaliation due to work-related grievances. Attorney Noblett informed the Council that Administration has authority over employees, but employees have been granted policies, such as the Whistleblower policy. Councilman Byrd questioned if there was anything prohibiting employees from talking with councilpersons. Attorney Noblett informed the Council that there is nothing prohibiting talking to councilpersons, as long as it does not interfere with the performance of their job.

# RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on nonagenda items. After which, Chairman Oglesby recognized the following persons:

During the 8-week academy, he learned about the job of a police officer and how different it was from what he knew prior to the academy. He highly encouraged minorities to become police officers.
- Steven Russell (SEIU Union Steward Finance) He would like for city employees to be treated fairly and feels that will be done by raising the minimum wage to \$15.00 per hour. He reminded the Council of the Mayor speaking recently on increasing wages. He believes that since Memphis and Shelby County have raised the minimum wage, the City of Chattanooga can also. He made himself available to speak with councilpersons on the matter.
- **Gloria Page** (Hamill Rd./District 3) She informed the Council that a government official who lives on Hamill Road wanted to retire and turn his house into a Short-Term Vacation Rental. That official was permitted to operate a STVR, but she lives on the same street and cannot. She asked for equity in STVR approvals.
  - Councilman Smith asked to speak with her after today's meeting.
- Jennifer Smith (District 6) She lives in District 6, but owns a house in District 1. She failed to contact Councilwoman Berz about her property, but will contact Vice-Chairman Henderson about it. She wanted to discuss STVRs with him and the fact that STVRs have increased property values.
