CALL TO ORDER

A hearing ensued, with Dallas Rucker, Director of Development Services, making a presentation that included the following: Site map of surrounding STVR applications, Google Earth map, Views of the structure/directional map and Application history. Chairman Oglesby then recognized the Applicant and members of the Opposition.

Applicants:

• Jason Burge – He informed the Council that he and his wife, Caitlin, live in Atlanta, but they spent a good amount of time looking for a community that was receptive to STVR. He had been told by the builder that STVRs were welcome in that community. This is the only property that they own. They have come to town and evaluated parking several times, and have always seen 6-8 open parking spaces in the complex. He would prefer to have more

long-term renters instead of those who come for the weekend. This is the only property they are wanting to use as a STVR.

• **Caitlin Burge** – They want to be a part of the community. They love coming to Chattanooga and want to keep the property.

Councilman Henderson discussed having no deed restrictions and no noise monitors. He also discussed his two concerns: noise and parking spaces. Mr. Burge informed the Council that they do have noise monitors, but would be willing to add them. He also confirmed that they are limited to one parking space for their property. Councilman Henderson indicated the need for adding conditions of the noise monitors and parking.

Therefore, **Councilman Henderson moved** to approve, with intent of amending. He was seconded by Councilman Ledford. The motion carried. **Councilman Henderson moved** to amend by adding two conditions: (1) installation of noise monitors and (2) limiting parking to one space. He was seconded by Councilman Smith. The motion carried. **Councilman Henderson moved** to approve as amended, seconded by Councilman Smith. The motion carried.

Business Improvement District (BID)

Attorney Noblett announced that the BID ordinance that has been placed on the agenda for first reading next week, May 28, 2019. He read TCA 7-84-513 and 514, detailing that a Council hearing must take place within 45 days following the filing of the initiating petition of owners. He confirmed that, according to state statute, the notice of the BID public hearing has run once a week for three consecutive weeks prior to the June 4, 2019 hearing. Councilwoman Berz questioned why the May 28 first reading had been scheduled prior to the June 4 public hearing. Attorney Noblett read the state statute

requiring the first reading prior to the public hearing. He also confirmed for Councilwoman Berz that the Council may defer the ordinance if there is an amendment to the BID boundaries.
