Anonymous Donation

This gift is specifically to support professional development of child care providers in curriculum implementation.

Chairman Oglesby informed the Council that Attorney Noblett became a grandfather last week. Attorney Noblett stated that Gabriel Joseph Noblett was born on July 13, 2019. He weighed 9.8 ounces.

Legislative Committee (Vice-Chairman Henderson not present)

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Oglesby recognized the following persons:

- Sylvester Harris (Curtis St.) He had concerns about the appointment of a retired police officer to the Police Advisory and Review Committee to which he also is appointed. He clarified not having a personal problem with the appointee or police officers, but does have concerns about being appointees to this particular committee being unbiased towards an organization they have been affiliated with in the past. He clarified that he did not come to persecute anyone or "go after" the police. He emphasized his support of the police and his desire for accountability. He believes the city would rather put a man in jail and house him for \$60,000 a year than put that money on the first part of his life. He wants a taxpayer, not a tax burden. It disturbs him to see that this city is ranked fourth for mismanagement. He wants us all to do the right thing. He reminded the Council that we all will one day be accountable. He hopes the Council and their families will look back at them and say that they did the right thing.
- Marie Mott (Oak Grove) She informed the Council that the last incident of police brutality in Chattanooga struck Councilwoman Coonrod personally. She thanked Councilman Gilbert being the only Council member who supported Councilwoman Coonrod at the press conference after the Hamilton County Sheriff's incident. She informed the Council that retired Assistant Chief Edwin McPherson and retired Captain Pedro Bacon were subpoenaed last week in the investigation of rape allegations. She commended Councilwoman Coonrod for her bravery in asking that the current Police Chief, who was over the Internal Affairs at the time of the alleged crime, to be investigated as well. She commented on the Council making a decision recently out of a comfort with the police. She noted that councilpersons do not know what it is to be an African American and be pulled over in their vehicle, be surveilled or have a stigma of color. She believes hindsight is 20/20. She asked the Council to think over its decisions and consider if we are seeing realistic outcomes. Have we liberated or She asked the Council to consider if the people have been liberated by any of its decision-making or place-making over the past three years for some and several years for others. She apologized to Councilwoman Coonrod for not having seeing the support of her colleagues. She emphasized that the community is standing with Councilwoman Coonrod.
- **Keeli Crewe** (Chattanooga) She is a business owner at 721 Broad Street. She reminded the Council of the city's mantra to rally the people, not run over them. She discussed how citizens were given the choice in funding infrastructure for fiber optics, participated in visioning meetings that led to the waterfront revitalization and private donations building

the Tennessee Aquarium. She believes the BID assessment will result in an increase the rent and shared taxes defined within their leases. She asked the Council to consider an alternative to the BID. She recommended that the Council convert the River City business model to a board membership, such as the Chamber of Commerce, Visitors Bureau. Green Spaces and Association of Visual Arts, all of which are member supported. She proposed that then the property owners advocating for the BID could become members and donate the same amount of the money based on property footage rather than setting up a self-imposed tax. As a member-supported organization, River City members could then be recognized for their tax-deductible altruistic support in all River City annual reports, advertisements and public relations. They could also be named as "corporate sponsors" for all future creative space-making, such as the Passageways, City Thread at Cooper's Alley and other public arts spaces. She suggested that membership donations could also be used to continue the weekly music in Miller Plaza and Miller Park, and the art and Farmer's Market at Waterhouse Pavilion. She informed the Council that New York City BIDs forced out many "mom & pop" businesses, due to increased cost and overhead. Ashville, NC and Alexandria, VA voted down a BID for this reason. Savannah dropped their BID after two years because of mismanagement of funds. She noted that New York City now has 74 BIDs. She discussed how the BID would set a precedence where a few unelected boards will determine the direction of a particular part of the city. She asked why create an additional tax when there are existing agencies working with city government to perform these services proposed by the BID?

- Denise Reed (Chattanooga) She represents the Concierge Office Suites, located at 633 Chestnut Street. She not only represents her own business, but also over 60 businesses that operate out of her business address for full-service office space within the footprint of the BID. She has spoken to several property owners against the BID who were absent while other property owners were advocating and believes they are "picking their battles." She listed several examples of how property owners have already contributed to the beautification of this city from their own private funds by revitalizing and/or repurposing such buildings as the McClellan, First Tennessee, Read House, Clemmons Building, St. Barnabas. She also noted how the Defoors brothers have invested more than \$88 Million downtown and plan to invest \$10 Million more.
- Darin Wright (Chattanooga) She is the owner of Elea Blake on Chestnut Street. Since Ms. Reed did not have time to finish her statements on behalf of the business owners, she wanted to continue reading the group's recommendations if this Council is determined to implement the BID. They propose amending the language of the BID so that none of the taxes may be passed through to lease tenants, business or residential. Despite what has been said in the contrary, she knows that taxes will be passed on to tenants because she has an email from her property manager that says so and includes the amount. The group recommends that the BID property owner's square footage assessment be published and that the donors be recognized in district programs. They recommend an audit after the first and subsequent years that will give insight into whether or not the BID is working. Regarding dissolution of the BID, they recommend adding language to the ordinance, like in LA, that will only requires the justification of the City Council to dissolve the BID, thus, eliminating the costly fees. She continued with her own personal recommendations to the Council. First came to Chattanooga, owned bus over 22 years, raised children here, takes her business seriously, not fond of politics, must take a stand to say "We must say 'no" to the BID, stand and protect those who are looking for the opportunity to innovate and build something great. Taxation without rep is a travesty. She has always invested in areas that are not desirable at the time. Pioneers like herself hope for personal success as well as the success of those in their communities. Despite hardships as a small business owners, she thrives through hard work and their own marketing. Small businesses are the lifeblood of every city. Small businesses donate 250-percent more than large businesses.

- Councilman Gilbert asked Ms. Wright the name of her business and if it is within the BID. She informed him that Elea Blake is within the BID. He informed Ms. Wright that some business owners were allowed to speak at the last BID hearing, and did not see a reason why she could not speak. Ms. Wright noted that there was some confusion as to whether only property owners may speak at the BID. She indicated that she did plan to be here for the hearing in the hopes of being able to speak.
- Rose Cox She owns the Palace Theatre on Patton Parkway. She stated that her business is dying due to all the taxes she must pay in this city. She pays taxes on so many things that does not need to pay at her other business in Florida. No told her how many taxes that she would have to pay in Chattanooga and no one ensures the mail delivers to taxpayers. She is still held responsible for taxes, even if the mail is not delivered to her. For her business in Florida, she only pays one income tax. She informed the Council that there are taxes written into her lease and believes there is no way around the taxes. She reminded the Council that she must pay musicians and artists no matter what the attendance at the venue. She pleaded for change this, or she will have to leave this city because she cannot afford to stay.
- Elea Wright (Chattanooga) She spelled her first name for the Council since it was misspelled in the record of the meeting last time she appeared before them. She wanted to finish a statement from a previous speaker: that small businesses donate 250-percent more than large business in community causes and also pay a greater share of taxes. She believes that is because (1) small businesses don't have expensive attorneys and tax accountants to help them get out of loopholes, and (2) small business owners want to support the communities they are in. She lives here and cares about the people. She informed the Council that small businesses were not consulted by the BID. Therefore, she has been going door-to-door, asking if they know what the BID is; yet, no one knows what it is. She informed the Council that BIDs in other countries, states and counties have pushed out many small businesses in the name of "improvement." She informed the Council that when they say small businesses will end up paying for this, they are accused of spreading misinformation when our landlords, despite being told this by landlords about how much more they'll pay monthly. She informed the Council of fights to stop the expansion of BIDs in New York City and the fight to stop BIDs entirely in Ashville, NC. She believes that people enjoy cities for their individuality, not because of their chain establishments or number of hotels. She believes that cities rich in small business culture are more favored. She asked the Council to consider more creative and sustainable ways options to a BID. She urged the Council not to allow small business owners to be pushed into a 10-year sentence with no voice. She argued that we must say 'no' to taxation without representation, 'no' to an unelected board that will handle our hard-earned money. 'no' to assessments that can increase 5-percent annually regardless of ROIs and 'no' to redundant expenditures and loopholes that allowed the BID to be resurrected as a resolution to circumvent the required 365 days before it could be resubmitted by the Tennessee legislation. She considers this ordinance to be the most undemocratic method for establishing the BID and considers it to be a slap in the face to small businesses that have built equity downtown and all Chattanoogans. She believes the right thing to do is listen to small business owners and create a more conducive environment for their success.
