Councilman Gilbert asked John Bridger, Executive Director of Regional Planning, to brief the Council on this item. Mr. Bridger gave a presentation that included pictures of the site and information on the zoning history of the property. Discussion ensued, with Councilman Gilbert asking Tommy Austin, the Applicant, about his intent with the property. Mr. Austin informed the Council that the back side floods, so it needs to be raised and then "flex spaces" would be added. Mr. Austin described flex spaces as light industrial buildings that serve as offices and shops for small businesses. Councilman Gilbert questioned Mr. Bridger on whether or not the uses could be limited just to flex spaces. Mr. Bridger indicated that the Land Development Office might not be able to enforce that particular term and that he would need to check the Zoning Ordinance.

Mr. Austin also informed the Council that he met with Regional Planning staff, who advised him to apply for M-2 so that he could not do any heavy industrial businesses. He also went to the North Brainerd Community Council and explained what he was planning to do. He informed the Council that the North Brainerd Community Council was in favor, but wanted to limit the property to light industrial as well.

Laid on the Table

Councilman Gilbert moved that this item be *laid on the table* until later in the meeting, allowing Mr. Bridger the time needed to make a recommendation about the flex spacing use. He was seconded by Councilman Byrd. The motion carried.

Taken from the Table

Two agenda items later, **Councilman Gilbert moved** to *take from the table*. At that time, Mr. Bridger recommended adding the language "*Warehousing and related uses*" to the ordinance as a condition. He informed the Council that the wording, "warehousing and related uses," would constrict uses such as a lumber yard or rug-cleaning plant.

Councilman Gilbert moved to approve with the intent to amend. He was seconded by Councilman Byrd. The motion carried. **Councilman Gilbert moved** to amend by adding a condition: "Warehousing and related uses." He was seconded by Councilman Byrd. The motion carried. **Councilman Gilbert moved** to approve as amended, seconded by Councilwoman Coonrod. The motion carried.

WWI USS LST 325

Councilman Ledford informed the Assembly of the USS LST 325 coming to Ross's Landing until August 27. He discussed the historical significance of this vessel. There will be tours from 10:00 a.m. to 1:00 p.m. Tours of the ship are free to WWII and Korean War veterans. Adults are \$10. Children ages 6-17 are \$5, and children 5 and under are free.

Police Academy Graduation

Councilwoman Berz attended the recent Police Academy Graduation and called it a "class act." She noted that this was the largest class of women to graduate and that the President of the class was a woman.

Minority Health Fair

Anthony Sammons, Deputy Chief of Operations, informed the Council about the 18th Annual Minority Health Fair that took place on this past Saturday. The organizers are finalizing all the findings with the partners. This year's fair exceeded 6,000 attendees. They have over 1,000 attendees who pre-registered this year. He thanked all those partners who provided services. He also thanked all the citizens for being concerned with their health. Chairman Oglesby commended Mr. Sammons for his leadership of this event.

The committee heard from Chief Roddy in open meeting today. Chief Roddy described how positions reserved for the committee members of the Police Advisory and Review committee members in the next Citizens Police Academy. Committee member information will be sent to Chief Roddy in the next day or two. Chief Roddy who will be in contact with the committee members about the academy.

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Oglesby recognized the following persons:

- Silvia Ramos (East Brainerd) She is a resident of East Brainerd and a proud board member of the YFD. She serves as the Senior Director for Education Initiatives at the United Way of Greater Chattanooga, providing leadership to our Chattanooga Early Learning Scholarship Program, also known as "CELS." She wanted to thank the City for its support of this program, which allows United Way to provide support to working low-income families whose increased earnings are too high to qualify them for public childcare assistance, but who would otherwise not have access to affordable high-quality early care and education. In the past year, CELS has worked with approximately 17 high-quality centers in the city. They have served 47 children ages 6 weeks- to 5-years-old, representing approximately 40 families on average. She noted that each child receives about \$235.00 a month in child care assistance and that recipients reside all over the city of Chattanooga. To illustrate the impact of the program, she told of one city employee who applied to the state for child care assistance and found out that the employee made \$16.00 too much each month to qualify for assistance. The employee attributes the CELS program with keeping her family from being on food stamps and her do the work she does for the city. She thanked the Council for investing in children and the stability of families.
 - Councilman Gilbert thanked Ms. Ramos for the report. He thought it was ironic that Ms. Ramos would speak about this tonight since the Council had talked about childcare earlier today and how an individual can, from what he believes, "make a dime" and get knocked out of services. He expressed his appreciation for what Ms. Ramos is doing for United Way.
- Sean Nix (Lee Avenue) He represents the "I Am" Foundation, the only black LGBT nonprofit in Chattanooga. He thanked Councilpersons Byrd and Coonrod for their personal donations to his organization for their upcoming event. He invited everyone to the I Am Foundation's upcoming Humanitarian Awards Luncheon, taking place on this Friday, August 23, 2019, at 6:00 p.m. at 1401 Gallery on Market. This year's Humanitarian Award recipient will be Dr. Elenora Woods, President of the local chapter of the NAACP. The Lifetime Achievement Award recipient will be Mayor Andy Berke.
- Marlena Russell (Drake Forest) She has been in Drake Forest since 2007 and has been asking for years about paving in the community. She has spoken to residents who have been there since the 1990's, asking for paving. She has talked to several people and thought the paving process had been started several times. Her last request was last year and her community was put on the list to have their streets paved during this year, but when she did not get a notice about the paving, she called for a status report. She was told that an engineer came through and decided that it was not important enough to be paved that they would look at it and come back and possibly fill in some of the potholes but our streets are worse than just potholes I actually have footage on my camera to show those streets since the 8th the 90s have not been repayed we have Pato it's the worst anybody that goes through Drake Forest knows that the neighborhood the houses are \$350,000 to over \$500,000 dollars. She informed the Council that the streets in the community are horrible. She recommended that the Council look up on any MLS to see what the houses are selling for in this community. She feels they should have nice streets and be able to come home without having to get a tire fixed. She informed the Council that she was recently driving down her own street and had to get a tire fixed because of the poor road condition.

Councilman Ledford informed the Council that Drake Forest was in his community and asked to speak with Ms. Russell after the meeting. Ms. Russell preferred speaking to Councilman Ledford in the public meeting so that others could get an understanding of the paving process. Councilman Ledford did not wish to discuss in the public meeting because he was not aware of what specifically she has been told by city representatives. He indicated that he is an advocate of paving and thinks it is fair for the City to lay out their case for what Ms. Russell has been told would happen. He, too, wanted to get more information about what has been said regarding paving in this area.
