The City of Chattanooga is an appropriate funder for these services as these sites will serve city residents almost exclusively and no other sources of private, state, or federal funding appear to be available for Cempa at this time. Proclamation Honoring Dennis "Buck" Saunders Read by Chairman Henderson on behalf of Councilman Mitchell

Chairman Henderson read the following proclamation:
