Attorney Noblett also confirmed that the land donation must come back before the Council and that reversion language has already been added to the agreement. Therefore, **Councilman Byrd** "moved the discussion," seconded by Councilman Mitchell. The motion carried. Councilman Byrd also informed the Assembly of neighborhood association meetings—Eveningside, Morningside and Highland Park—where this agreement will be discussed.

Charles Young, ECD's Assistant Director of Development, gave a presentation on the application that included the following:

- Surrounding STVR applications
- Aerial view
- Street views
- Application History

A hearing ensued, with Vice-Chairman Henderson recognizing the Applicant and members of the Opposition.

Applicant:

David Luzurigga – He and his wife bought this house in November. The prior owner used
it for short-term rentals. He has completed all requirements on the application checklist. He
has met with the neighbors, and brought one letter of support from one neighbor adjoining
his parking area. From what he understood, the two letters of opposition had been
rescinded.

Opposition:

 Lynn Rutherford (Ochs Highway) – She lives next door to this property and opposes nonowner occupied STVRs because guests will be strangers in the neighborhood. She would prefer real neighbors. The property feels more like a hotel to her, as if no one is living there. She gave examples of her neighbors helping her at various times in life. She, too,

collaborates with her neighbors, dealing with kudzu and flooding, for instance. She does not feel safe living next to an STVR. The previous owner did use the house as an STVR, but that former owner also lived in the St. Elmo community.

• **Jeff Malvo** (Ochs Highway) – He does not like neighbors with a rotation of house guests. He spoke on the "use value" and "exchange value" for this property, neither of which are benefitting people in Chattanooga, he argued. He believes St. Elmo is becoming transient due to the number of STVR. He reminded the Council that Nashville has banned non-owner occupied STVRs because of the impact on neighborhoods. He noted that there are two more STVR applications pending in the area after this case. He believes that long-term family tenancy would be more profitable for the community.

Chairman Oglesby informed the Council of meeting with the Applicants as well as the surrounding neighbors. Therefore, **Chairman Oglesby moved** to approve, seconded by Councilman Byrd. The motion carried, with Councilwoman Coonrod voting "No."
