May 19, 2020 6:00 PM

Councilwoman Coonrod informed the Council that she had spoken to the Applicant, Jerri Price, who asked for this item to be deferred since the bank was having problems due to the COVID-19 emergency. Councilwoman Coonrod also questioned if this was supposed to be listed as a second reading instead of a first reading. John Bridger, Executive Director of Regional Planning, joined the discussion to confirm the second reading and recalled a first reading already. Attorney Noblett indicated that the Clerk could confirm the reading from past minutes. Attorney Noblett also noted that this is the Alternate Version 2, which indicated past revision from a first reading.

Chairman Henderson asked Ms. Price if deferring to June 9 would work for her. She had no problem with that date. Councilman Mitchell suggested the alternative of tabling the matter until the bank issues could be resolved. Ms. Price agreed.

Lincoln Park Update

Councilman Byrd brought back a conversation that Councilwoman Coonrod had today about Lincoln Park. He requested an update on the funding for Lincoln Park and requested that it be heard in ECD Committee. Chairman Henderson asked Councilman Oglesby to schedule the update in committee soon. Councilman Oglesby agreed.

COVID-19 Rent & Utility Assistance

Councilman Oglesby announced that ECD will reopen its COVID-19 Rent and Utility Assistant Program for individuals impacted by the pandemic. The application period will be June 1 – June 30, 2020. The original round had funds remaining. He reminded everyone of the eligibility for applying. The application will be available online on June 1. ECD will mail applications upon request. For additional information, he gave the phone number for Donna Williams, ECD Administrator, at (423) 643-7312.

Reopening YFD Sites

Councilwoman Coonrod asked for an update on the reopening of YFD sites. Maura Sullivan, Chief Operating Officer, joined the discussion and informed the Council that Administration is still evaluating the governor's orders and limitations on when these centers can be opened. She informed the Council that Administration is looking at June 15 for opening pools but noted that is not a hard date.

District 8 - COVID-19 Testing

Councilman Byrd announced COVID-19 testing coming to the Avondale YFD center on tomorrow, May 20, from 10:00 a.m. to 3:00 p.m.

Also, Councilman Byrd announced that the Office of Multicultural Affairs is seeking volunteers for COVID-19 testing at Whiteside's Faith Manor on May 21-22. The contact person for volunteers is Karen McReynolds, who may be reached at (423) 933-5800.

Councilman Ledford thanked Administration for partially re-opening Heritage Park in District 4. He asked Administration to consider how to re-open the dog park at Heritage Park. Ms. Sullivan indicated that they are evaluating that as well.

Universal Vote By Mail

Councilwoman Coonrod informed the Council that she has spoken with Attorney Noblett about election security with the upcoming election. She asked the Council to support her in drafting a resolution to send to the Election Commission and the State of Tennessee to allow "Universal Vote by Mail" that would cover all age groups in light of the pandemic. She wants to ensure everyone having the opportunity to vote, especially with concerns about safety and PPE supplies. Three councilpersons—Oglesby, Gilbert, and Byrd—agreed to sponsor the legislation with Councilwoman Coonrod. Attorney Noblett agreed to prepare it for the Council's agenda.
