COUNCIL MEETING MINUTES

June 2, 2020 6:00 PM

CALL TO ORDER

Council Chairman Chip Henderson called the meeting to order by electronic means. A quorum was present via electronic means that included Vice-Chairman Ken Smith and Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, Darrin Ledford, Jerry Mitchell and Erskine Oglesby, Jr. Also in attendance were Phil Noblett, City Attorney, and Nicole Gwyn, Council Clerk, both via electronic means. Regarding PO557744, Chairman Henderson inquired about the need for the security contract, to which Mr. Sammons responded. Regarding PO557745, Councilwoman Coonrod informed the Council that she is a franchise owner with Jan-Pro and, therefore, would recuse herself from any consideration on that emergency purchase. Attorney Noblett affirmed her recusing herself from consideration on that one purchase.

<u>Additional Emergency Purchase:</u> <u>Tennessee Waste Haulers</u>

Mr. Sammons also informed the Council of an emergency purchase for refuse and recycling services for 30 days with an existing contractor, Tennessee Waste Haulers, that will fill a gap between the time that a new contract is potentially installed, while continuing the services at the refuse collection centers and recycle collection centers. Chairman Henderson asked Attorney Noblett about the usual process of signing letters in the open meeting for emergency purchases. Attorney Noblett informed the Council that, per the Governor's Executive Order during the COVID-19 emergency, electronic signatures were acceptable on the letters. He also noted that a report of the circumstances has been filed with the purchasing agent and entered into the minutes of this meeting.

Reconsidering Purchase R197304

Regarding a purchase that was tabled last week, **Councilman Ledford moved** to take R197304 (Public Works) off the table. He was seconded by Councilman Mitchell. Justin Holland, Public Works Administrator, was brought into the panel to discuss the need for this purchase order. After which, the motion carried unanimously (9-0) upon roll call vote.

A RESOLUTION AUTHORIZING COLLINS AND COMPANY TO PAY AN ONTHE-JOB INJURY SETTLEMENT TO CITY EMPLOYEE, GREGORY NEAL, FOR A PERMANENT PARTIAL IMPAIRMENT RATING IN ACCORDANCE WITH THE CITY'S INJURY-ON-DUTY POLICY, IN THE AMOUNT OF THIRTY THOUSAND NINE HUNDRED SEVENTY-FOUR AND 35/100 DOLLARS (\$30,974.35).

RESOLUTION #30386

A RESOLUTION AUTHORIZING COLLINS AND COMPANY TO PAY AN ONTHE-JOB INJURY SETTLEMENT TO CITY EMPLOYEE, LIBERTY SUITS, FOR A PERMANENT PARTIAL IMPAIRMENT RATING IN ACCORDANCE WITH THE CITY'S INJURY-ON-DUTY POLICY, IN THE AMOUNT OF SIXTY THOUSAND TWENTY-SEVEN AND 98/100 DOLLARS (\$60,027.98).

These offers exceeded the \$25,000 threshold, so Attorney Noblett requested approval from the Council. **Councilman Ledford moved** to approve, seconded by Councilwoman Berz. The motion carried unanimously (9-0) upon roll call vote.
