# **COUNCIL MEETING MINUTES**

June 23, 2020 6:00 PM

## **CALL TO ORDER**

Council Chairman Chip Henderson called the meeting to order by electronic means. A quorum was present via electronic means that included Vice-Chairman Ken Smith and Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, Darrin Ledford, Jerry Mitchell and Erskine Oglesby, Jr. The following panelists were also present at the call to order: Phil Noblett, City Attorney; Lydia Christoph, Administrative Support; and Nicole Gwyn, Council Clerk. ## **ORDINANCE #13575**

AN ORDINANCE TO AMEND ORDINANCE NO. 13473, HEREINAFTER ALSO KNOWN AS "THE FISCAL YEAR 2019-2020 OPERATIONS BUDGET", PROVIDING REVENUE FOR THE FISCAL YEAR BEGINNING JULY 1, 2019, AND ENDING JUNE 30, 2020; APPROPRIATING SAME TO THE PAYMENT OF EXPENSES OF THE MUNICIPAL GOVERNMENT; FIXING THE RATE OF TAXATION ON ALL TAXABLE PROPERTY IN THE CITY, AND THE TIME TAXES AND PRIVILEGES ARE DUE, HOW THEY SHALL BE PAID, WHEN THEY SHALL BECOME DELINQUENT; PROVIDING FOR INTEREST AND PENALTY ON DELINQUENT TAXES AND PRIVILEGES; AMENDING CHATTANOOGA CITY CODE, PART II, CHAPTER 2, SECTION 2-267, RELATIVE TO PAID LEAVE FOR ACTIVEDUTY TRAINING AND TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 31, SECTIONS 31-36, 31-37, 31-41, AND 31-43, SECTIONS 31-322 AND 31-354.

Councilwoman Berz informed the Council that Daisy Madison, Chief Finance Officer, was recommending the addition of certain clarifying language to this ordinance and read the statements into the record of the meeting.

WHEREAS, pursuant to T.C.A. § 6-56-205, a governing body shall not make any appropriations in excess of estimated available funds, except to provide for an actual emergency threatening the health, property or lives of the inhabitants of the municipality; and

WHEREAS, President Donald Trump declared COVID-19 a public health emergency under the Public Health Service Act on January 31, 2020, issued two national emergency declarations under both the Stafford Act and the National Emergencies Act on March 13, 2020, and invoked emergency powers via an Executive Order under the Defense Production Act on March 18, 2020; and

WHEREAS, on March 12, 2020, Governor Bill Lee issued an Executive Order declaring a state of emergency to facilitate the treatment and containment of COVID 19; and

WHEREAS, on March 19, 2020, Mayor Andy Berke declared a state of emergency to the City of Chattanooga in response to the COVID-19 pandemic; and

WHEREAS, on April 12-13, 2020, an extensive storm involving multiple tornados, flash flooding, and high water damages resulted in death and injury to persons and destruction of property in large areas of the City of Chattanooga.

Ms. Madison explained the necessity of this ordinance amendment. **Councilwoman Berz moved** to amend. Vice-Chairman Smith seconded. The motion carried unanimously (9-0) upon roll call vote. **Councilwoman Berz moved** to approve as amended. Councilman Ledford seconded. The motion carried unanimously (9-0) upon roll call vote.

# **Settlement Agreement**

Attorney Noblett informed the Council of a Consent Decree contract settlement for W140006-201 to 3D Enterprises for \$85,003.41, which would resolve any claims for extra work done in connection with a large clarifier upgrade at Moccasin Bend. He informed the Council that this settlement was his recommendation as well as the management at Public Works, and that it was a budgetary amount already within the Public Works budget.

# Office of Community Resilience

Councilman Byrd expressed his thanks to his colleagues for their work on this year's budget and thanked Administration for funding invested into the Office of Community Resilience. He asked the Mayor's staff to include the following organizations to work with the new office: Christmas in District 8 – Malarie Marsh; PPCH - Allen Green; Reach One Teach One – Reggie Yearby; Fatherly Figure - Tee Johnson and Brandon Woodruff; I Am Foundation – DeAngelo Davis; and the Urban Policy Institute – Dennis Clark and Deborah Johnston.

Councilwoman Coonrod also expressed her thanks to her colleague on the Council and administration for adjusting the budget. She will email Administration a list of organizations that are doing great work in the community and that she would like to see the Office of Community Resilience. She noted that these organizations are not seeking funding. She would also like to see a change in the budget process and public engagement and recommended having multiple budget sessions in all districts in the new fiscal year.

# **Hamilton County Sheriff's Info**

Councilwoman Coonrod mentioned a video from May 23 showing Hamilton County deputies beating a black man.
