COUNCIL MEETING MINUTES

June 30, 2020 6:00 PM

CALL TO ORDER

Council Chairman Chip Henderson called the meeting to order by electronic means. A quorum was present via electronic means that included Vice-Chairman Ken Smith and Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Darrin Ledford, Jerry Mitchell and Erskine Oglesby. Other panelists present via electronic means: Phil Noblett, City Attorney; Lydia Christoph, Administrative Support; and Nicole Gwyn, Council Clerk. Councilman Byrd led the Assembly in the Pledge of Allegiance.

APPROVAL OF LAST MINUTES

AN ORDINANCE TO AMEND ORDINANCE NO. 13473, HEREINAFTER ALSO KNOWN AS "THE FISCAL YEAR 2019-2020 OPERATIONS BUDGET", PROVIDING REVENUE FOR THE FISCAL YEAR BEGINNING JULY 1, 2019, AND ENDING JUNE 30, 2020; APPROPRIATING SAME TO THE PAYMENT OF EXPENSES OF THE MUNICIPAL GOVERNMENT; FIXING THE RATE OF TAXATION ON ALL TAXABLE PROPERTY IN THE CITY, AND THE TIME TAXES AND PRIVILEGES ARE DUE, HOW THEY SHALL BE PAID, WHEN THEY SHALL BECOME DELINQUENT; PROVIDING FOR INTEREST AND PENALTY ON DELINQUENT TAXES AND PRIVILEGES; AMENDING CHATTANOOGA CITY CODE, PART II, CHAPTER 2, SECTION 2-267, RELATIVE TO PAID LEAVE FOR ACTIVE-DUTY TRAINING AND TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 31, SECTIONS 31-36, 31-37, 31-41, AND 31-43, SECTIONS 31-322 AND 31-354.

OTHER BUSINESS:

Youth Highlight

Councilwoman Coonrod informed the Council that Troy Rogers (Public Safety) and "Uncle Joe" (YFD) had fostered relationships with Brainerd student named Eric Moses, who had lost his parents in 2011 due to gun violence. She spoke on how the young man was going down the wrong path until he met Uncle Joe. She reported that the young man eventually turned around his own life, got accepted into the honor society, and now has a full ride scholarship to Tuskegee. She emphasized the need to hear positive stories about youth and those working in the city to assist youth.

Pandemic Lessons

Councilwoman Coonrod commented on learning political lessons related to the pandemic health response. She commented on pandemic responses by the Hamilton County government that affect

the City Council and Mayor. She encouraged residents to wear a mask and adhere to all other CDC guidelines at this time. Councilman Gilbert echoed Councilwoman Coonrod's warnings about wearing masks for the protection of others.

Juneteenth Salute

Councilman Byrd commended Cempa Community Care and LaDarius Price for making this year's Juneteenth a paid holiday for Cempa employees. He thanked his colleagues for the Juneteenth legislation passed weeks ago. He, too, warned residents to take COVID-19 serious.

COVID-19 News

Chairman Henderson informed everyone that there were COVID-19 exposures this past Saturday at two high school graduations: Central High and Hixson High. He encouraged everyone who attended those graduations to get tested.
