CALL TO ORDER

Council Chairman Chip Henderson called the meeting to order by electronic means. A quorum was present via electronic means that included Vice-Chairman Ken Smith and Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, Darrin Ledford, Jerry Mitchell and Erskine Oglesby, Jr.. Avondale YFD Center Damage

Councilman Byrd informed the Council about a car hitting the front of the Avondale YFD Center this weekend. He discussed the concerns that he and the community had about the center being close to the street, a large pedestrian presence in the area, and the traffic study. He discussed the urban design and loading/unloading that takes place in the back parking lot. Maura Sullivan, Chief Operating Officer, joined the panel to discuss the bid process for repairing the center. She also discussed the "Road Diet" that will take place.

Paid Holiday Request

Councilwoman Coonrod inquired about the process of adding Juneteenth as a paid city holiday. Attorney Noblett informed the Council that adding a holiday would require a budget amendment, adding to the HR plan, and legislation from the Council. He indicated that he would need the numbers from the Daisy Madison, Chief Finance Officer, and Ms. Sullivan in order to draft legislation. Chairman Henderson asked Councilwoman Coonrod to work with Ms. Madison on this request.

Mask Mandate

Councilwoman Coonrod discussed the mask mandate by the Hamilton County Mayor. She asked people to imagine how people felt living with "Colored only" signage in history. She then commented on pushing for changes for black, brown, Latino, and poor white communities.
