COUNCIL MEETING MINUTES

September 22, 2020 6:00 PM

CALL TO ORDER

Council Chairman Chip Henderson called the meeting to order by electronic means. Charles Young, ECD Assistant Director of Development, gave a presentation that included information on the surrounding STVR, pictures, and application history.

The Applicant, Spencer Wakefield, was not present at this meeting. Chairman Henderson recognized the following members of the Opposition:

Ken Hays - Six neighbors adjoined to this property have signed a petition asking the
council to deny this STVR application. Fort Negley neighborhood is small, consisting of
two main streets with the side streets, but there are already twelve STVR non-occupied
units in this area. This recent development has nineteen units, but in a matter of three
weeks, there have been two STVR applications. They do not want a lot of you short-term
rentals occurring such a dense environment.

Councilman Oglesby moved to deny. Councilman Byrd seconded. The motion carried unanimously (9-0) upon roll call vote.

Budget Item Follow-up
